# Pam fod Chwarae, Dysgu a Gofal Plentyndod Cynnar yn bwysig?

## Why does ECPLC matter?

- Mae gan blant hawl gyfreithiol sylfaenol i dyfu i fyny mewn amgylchedd hapus, iach a diogel.
- Rydym am i Gymru fod yn lle gwych i bob babi, plentyn ifanc, eu teuluoedd a'u cymunedau ffynnu.
- Dylai pob baban a phlentyн ifanc gael cyfleoedd a phrofiadau ar gyfer mwynhad, hwyl a chreadigrwydd.
- Mae hwn yn gyfnod o dwf cyflym a datblygiad yr ymennydd sy'n cael ei siapio gan eu profiadau, amgylcheddau a'r oedolion sy'n eu cefnogi. Mae dystiolaeth wedi dangos mai ECPLC sy'n cael yr effaith fwyaf ar hyn o bryd.

- Children have a fundamental legal right to grow up in a happy, healthy and safe environment.
- We want Wales to be a wonderful place for all babies, young children, their families and communities to thrive.
- All babies and young children should have opportunities and experiences for enjoyment, fun and creativity.
- This is a time of rapid growth and brain development which is shaped by their experiences, environments and the adults who support them. Evidence has shown that ECPLC has the most impact at this stage.

### ECPLC- Quality



- Ecwiti yn y ddarpariaeth lle mae darpariaeth o ansawdd yn seiliedig ar yr un ddealltwriaeth o ddatblygiad plentyn waeth beth yw lleoliad y plentyn (a gynhelir, na chynhelir, ADY, Canolig Cymru neu ddarpariaeth awyr agored).
- Mae ymarferwyr yn deall sut mae elfennau proses a strwythurol y ddarpariaeth yn gweithio gyda'i gilydd a pham eu bod yn bwysig mewn cylchoedd ansawdd gan gynnwys rôl arolygu
- I rieni ddeall darpariaeth a phrofiad dysgu eu plant ni waeth beth yw'r lleoliad.
- Cyfres o adnoddau!
- Equity in provision where quality provision is based on the same understanding of child development regardless of the child's setting (maintained, non-maintained, ALN, Welsh Medium or outdoor provision).
- Practitioners understand how both process (e.g. Curriculum) and structural elements of provision work together and why they are important
- For parents to understand provision and the care and learning experience of their children no matter what the setting.
- A suite of resources!

- Sefydlodd Grŵp Tasg a Gorffen Fframwaith Ansawdd Chwarae, Dysgu a Gofal Plentyndod Cynnwr haf 2020, dan gadeiryddiaeth yr Athro Karen Graham.
- Cynrychiolwyr o bob rhan o'r sector Chwarae, Dysgu a Gofal Plentyndod Cynnwr - gan gynnwys AGPC, Umbrella orgs, Arolygiaethau, a Gynhelir a Heb eu Cynnal, Plant yng Nghymru mae'r rhestr yn mynd ymlaen!
- Mae'r Grŵp T&F wedi cydweithio'n agos i gyd-gynhyrchu Fframwaith Ansawdd Chwarae, Dysgu a Gofal Plentyndod Cynnwr drafft.
- An ECPLC Quality Framework Task and Finish Group was established summer 2020, chaired by Professor Karen Graham.
- Representatives from across the ECPLC sector – including practitioners, EYAT's, Umbrella orgs, Inspectorates, Maintained and Non-Maintained, Children in Wales the list goes on!
- The T&F Group has worked closely together to co-produce a draft ECPLC Quality Framework.


## What is the Quality Framework?

- disgrifio'r egwyddorion cyffredinol a ddylai fod yn ganllaw i bob lleoliad/ysgol a phob ymarferydd
- Dylid defnyddio'r Fframwaith Ansawdd hwn i lywio ymarfer. Dylai helpu ymarferwyr i:
  - ✓ ymgorffori hawliau pob plentyn o fewn ymarfer
  - ✓ cefnogi dysgu a datblygiad cyfannol pob plentyn, gan gynnwys eu datblygiad corfforol, emosional-gymdeithasol, gwybyddol a chyfathrebu
  - ✓ cynllunio darpariaeth effeithiol, ei rhoi ar waith a'i hadolygu
  - ✓ ymgymryd ag ymarfer myfyriol
  - ✓ cefnogi cyfnodau pontio effeithiol o'r cartref/lleoliad/Ysgol
  - ✓ nodi anghenion dysgu proffesiynol a chymhwysterau
  - ✓ llywio prosesau hunanwerthuso a gwella ochr yn ochr ag adhoddau sicrhau ansawdd y sector
- describes the common principles of what quality provision is
- should be used to inform practice. It should help practitioners to:
  - ✓ embed all children's rights into practice
  - ✓ support the holistic development and learning of all children including their physical, social-emotional, cognitive and communication development
  - ✓ plan, implement and review effective provision
  - ✓ engage in reflective practice
  - ✓ support effective transitions from home/setting/school
  - ✓ identify professional learning needs and qualifications
  - ✓ inform self-evaluation and improvement processes alongside sector quality assurance tools.

# Strwythur y Fframwaith Ansawdd

## Structure of the Quality Framework

Mae Fframwaith Ansawdd Chwarae, Dysgu a Gofal Plentyndod Cynnar yn cynnwys pedair adran ac fe'i cefnogir gan Offeryn Ymarfer Myfyriol a'r Llwybrau Datblygu ar gyfer plant 0-3 oed.

**Adran 1:** Gosod y Sylfeini ar gyfer darpariaeth ac Ymarfer Chwarae, Dysgu a Gofal Plentyndod Cynnar o ansawdd.

**Adran 2:** Rôl yr oedolyn galluogi, pwysigrwydd profiadau deniadol a phwysigrwydd amgylcheddau effeithiol.

**Adran 3:** Cefnogi fi, cefnogi datblygiad

**Adran 4:** Ymarfer sy'n canolbwytio ar blant

- The ECPLC Quality Framework consists of four sections and is supported by a Reflective Practice Tool and the Development Pathways for 0-3 year olds
- **Section 1:** Laying the Foundations for quality Early Childhood Play, Learning and Care provision and Practice.
- **Section 2:** The role of the enabling adult, The importance of engaging experiences and The importance of effective environments.
- **Section 3:** Supporting me, supporting development
- **Section 4:** Child-centred practice

- Co-constructed by practitioners, WG officials, Estyn and CIW.
- support individuals and teams to reflect on the quality of early childhood play, learning and care.
- draws together the various requirements for delivering the type of high-quality care, education and play provision needed in Wales
- It will support practitioners to continually improve the quality of their practice to support the children in their learning and development.



- Mae'r Llwybrau Datblygiadol ar gyfer plant 0-3 oed yn nodi fframwaith ar gyfer sicrhau darpariaeth o ansawdd i bob plentyn o'i enedigaeth hyd at 3 oed.
- Maent yn cymryd y pum Llwybr Datblygiadol (perthyn, cyfathrebu, archwilio, datblygiad corfforol, lles) ar gyfer plant 3 a 4 oed sydd eisoes wedi'u cyhoeddi mewn cwricwlwm ar gyfer lleoliadau meithrin a ariennir nas cynhelir ac yn eu hymestyn o blant 0-3 oed.
- Maent wedi cael eu cyd-adeiladu gydag ymarferwyr ac arbenigwyr ar draws y sectorau addysg a gofal plant.

- The Developmental Pathways for 0-3 year olds sets out a framework for ensuring quality provision for all children from birth to age 3.
- They take the five Developmental Pathways (belonging, communication, exploration, physical development, well-being) for 3 and 4 year olds which are already published in a curriculum for funded non-maintained nursery settings and extends them from 0-3 year olds.
- They have been co-constructed with practitioners and specialists across the education and childcare sectors.
