
Button batteries

Particularly lithium coin cell batteries, can be deadly if a small child swallows one and it gets stuck in their windpipe. The reaction in the child's throat can kill in less than two hours. Button batteries power so many essential things in our homes like car key fobs, slim remotes, kitchen and bathroom scales, children's thermometers and more. Spare and old batteries can cause problems too.

Advice for families:

The simplest way to reduce the risk is to store button batteries out of children's reach. Check the compartment of products with lithium coin cell batteries to make sure they are secure and don't let children play with them.

Guidance for employers:

Consider: How [your] use of a smartwatch may impact on your child protection policy and procedure, privacy and confidentiality policy and staff code of conduct

Provide: Secure locker/room for staff to store valuable items when on duty
